

Rules & Regulation for Pharma's Got Talent 2022 (#PGT 2022) Audition / Participation

- 1. Age should be above 18 years.
- 2. The participant should be an Indian citizen. & working in Pharma Company as employee or in direct business of Pharma Product & service Promoter / business owner.
- 3. A group act should submit their Participation Forms together.
- 4. Maximum number of participants in an act is 8 (Eight).
- 5. PGT 2022 Online Registration Opens on 11th Jan 2022,on https://pharmaconnect.co.in/pgtregistration/
- 6. Fill all the details in the registration form
- 7. Upload your performance video for the audition. Size should be less than or equal to 100 MB, Not more than 3min duration
- 8. The video file format should be in mpg, MPEG, Avi, mp4, or mov.
- 9. Click on the Submit Button "I agree to the terms and conditions."
- 10. Hit the submit button.
- 11. Wait for the response from the Portal, https://pharmaconnect.co.in/
 (you will get activation Link to reconfirm your Email id , Copy Link in your Login Credential on Browser and complete your registration
- 12. Alternatively, you can also furnish all the details accompanied by audition video at info@pharmaconnect.co.in/ pharmaconnect21@gmail.com
- 13. You can Tag #pharmaconnect, #Funatwork & #PGT when you submit your Nomination on social media
- 14. Your registration will be completed in either way.
- 15. Pharma's Got Talent 2022 Auditions will close on 13th Feb 2022, Onwards
- 16. Will be accepted on Online format only
- 17. The candidate should agree and abide by the terms and conditions of PGT 2022
- 18. Finalisation of finally entries will be on 13th Feb 2022,Onwards
- 19. Grand Finally 26 Feb 2022 / 5th Mar 2022
- 20. Pharma Connect all rights reserved for PGT 2022 to change in programme, schedule, criteria, Nomination or cancellation
- 21. In all cases, decisions of the judges are final and will not be open to discussion.
- 22. Absolutely no profanity or insensitive subject matter will be permitted.
- 23. Costumes and all required probes will be arranged by participant only
- 24. All performances will be screened for appropriateness by the Talent Show (PGT) Committee.
- 25. You shall not have any kind of project with the third party of the show
- 26. If you act requires recorded accompanying music, the music must be: Provided to the Talent Show Committee at the time of the auditions. The CD/ Pen Drive must be labelled with your name and song name.

- 27. There will be prizes given for 1st, 2nd and 3rd places.
- 28. Candidate may be required to provide registration information in order to access the Pharma Connect. You must provide correct, current and complete information. You are responsible for updating and maintaining the truth and accuracy of such information. You agree that we may take steps to verify the information you provide, including contact information for a parent or guardian.
- 29. Candidates have no criminal background
- 30. PGT 2022, on approval of application you have to submit Valid government identification proof such as Aadhar Card / Driving Licence / PAN Card / Passport / Voter Identity Card
